this clinic:	 This clinic is a requirement for all Canadian judges that will judge at NORAMS, Junior Nationals, Senior Nationals, Canadian Series, and Canadian Open Tour events this 2016/2017 season. This clinic is open to B and C level judges as well as judges who need to upgrade from D to C level of FIS certification. The AFP Halfpipe/Slopestyle/Big Air segments are open to all levels of judge Certification. This is an educational opportunity for judges who are interested in high performance judging and keen to improve their skills. Performance athletes and coaches who are interested in understanding the judging criteria and process are welcome to attend and encouraged to participate. All participants must have a current FC or USSA judge license and be a member in good standing.
**AFP judge training update	NEW FOR 2015/16. Canadian Judges wishing to access AFP training must purchase a FC judging license at which time they will receive an access code for AFP online training and testing at no extra cost. This reflects AFP and CFSA commitment to partner in training a quality pool of judges for all Freestyle events, and to create fair and equitable access to education and certification
	**All judges attending the AFP portion of the clinic must complete the AFP online course and test, prior to attending the clinic. (All judges have until 2 weeks prior to the Calgary clinic to complete the AFP course and test). *Judges will receive update emails on the status of the AFP online course once registered for the Calgary clinic.
