Josh Dueck

- Josh Dueck recognizes membership, welcomes Simon Lemieux (new BC Team mogul coach) and recognizes Josh Kober (past coach) for his contribution to the BC Mogul Team. Praise for staff: Cameron Smith and Tom Swiecicki. Josh Dueck: additional ViaSport grants secured this year thanks to efforts of staff (Cam/Tom)
- Josh Dueck highlights the strength of the organization coming out of the pandemic and the important role SafeSport has played and continues to play in the success of our organization.
- Josh Dueck mentions we are keenly aware of the shuffle happening in government at the present time and are working to diversify FBC revenue streams to ensure stability and solvency of theorganization.

Financial Statement Report

Adrienne Staley

- Maintain a balance budget
- Revenue:
 - 36% Viasport
 - 19% Competitions
 - 14% Membership
 - 11% Gaming
 - 5% Grants
- BC Teams ran 36% deficit due to inflated costs during covid and other
- Increased expenses directly attributable to increased revenue and operations
- Board decision pending for what elements of revenue processing can be done by FBC and local clubs for Timber Tour. FBC is aware of membership requests and making strides to accommodate where possible.
- Large increase in member revenue due to member increase of 31%
- Increase in expenses due to travel, covid expenses, increased communication, etc.
- Overall, 11% Deficit forecast, 5% deficit actual
- Investments made in Coach/Officials Development and FBC Communication Plan
- Plan to increase investment in membership services, marketing, communication, and keeping kids safe with initiatives including SafeSport.
